ARGUMENT

Defendant Pillonato's Answer to the Receiver's Motion is moot. On November 5, 2018, this Court granted the Receiver's Motion and ordered the Department of Homeland Security to turn over the \$109,020 in cash currently in its custody to the Receiver to hold until further order of the Court [ECF No. 202]. Additionally, the Court retained jurisdiction to adjudge any claims, including those made by Jeremy Valentino, to the \$109,020. *Id.*
