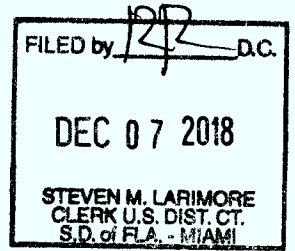

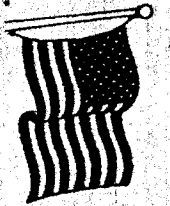
This cause having come before this Court on Defendant's Dustin Pillonato and Justin Ramsey's Motion for Return of Seized Property, it is:
